The Village Clinic Gets Facelift

The NALV Director/CE, Professor Ibrahim Muhammad on assumption of duty has started embarking on improving the health facilities at the village, in his effort to ensuring that, he has upgraded and equipped and stoked the village clinic with drugs and other essential needs.

Before the appointment of Prof. Ibrahim Muhammad the clinic had no single doctor to provide consultancy services in the clinic. However, realizing the none availability of doctoring the clinic, Professor Ibrahim Muhammad paid a courtesy visit to the CMD University of Maiduguri Teaching Hospital (UMTH) and requested for the services of consultants to the village clinic. That request was properly approved by the CMD. Right now two consultants were posted to the village clinic by the authority of the UMTH. Over 80%

of the village staff are patronizing the UMTH under the National Health Endurance Scheme NHIS.

The NALV Director/CEO had ordered for the purchase of:

- Essential drugs for the clinic.
- Laboratory equipment were purchased.
- 1200 KVA was purchased for the clinic
- Drugs imprest was also approved for the clinic.
- The clinic has also under gone a major facelift with painting and many more.

Due to the latest transforming in the clinic, a number of senior and junior staff are attracted and many start to transfer their NHIS to the village facilities. With this development, the consultants from UMTH will be visiting the village clinic twice a week.


The NALV Management at the International Scientific Symposium
